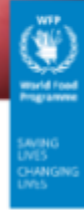

Conference | Strengthening Social Cohesion: Advancing Operations, Programming, and Evidence

Investing in social cohesion can play a critical role in improving the effectiveness of development and humanitarian programs. This is particularly true in the current context, characterized by a range of ongoing crises, including the COVID-19 pandemic, climate change, and the global economic slowdown, which are exacerbating social fragmentation, fueling tensions within and between individuals from a diversity of communities, and

weakening social contracts.

On December 5, IPA, The World Bank, and Mercy Corps organized a conference on social cohesion. The goal was to disseminate evidence and lessons learned on strategies to measure and reinforce social cohesion while highlighting operational implications for policymakers and practitioners.
