<b>Question 1:</b>	How many courses do you wish to deploy to your workforce on a yearly basis? You list 8 courses in the RFP. We do three year contracts in our firm. Do you prefer to split those 8 across 3 years or will it be 8 courses each year?
<b>Answer:</b>	We anticipate running up to 8 courses each year, but would like the flexibility to choose how many to deploy in a given year. (For example, some years we might deploy all of them; some years we might deploy only 2-3.) Please suggest a pricing system that takes this into account.
<b>Question 2:</b>	What is your timeline? When do you need a vendor in place?
<b>Answer:</b>	We anticipate concluding the contacting process by mid-Sept and completing setup with the selected vendor by mid-Nov.
